

Irish Tillage and Land Use Society Membership



Membership of the Irish Tillage and Land Use Society (ITLUS) is available to anyone within the agricultural sector, subject to the agreement of the Council of ITLUS. The Society aims to provide education, experience, social and travel opportunities for its members. Each year the Society organises a workshop or seminar in springtime, a summer field meeting to somewhere on the island of Ireland, and a topical conference in early December. In addition, every second year it organises a foreign study tour to experience agricultural production elsewhere in the world. It is also a co-organiser of the Agricultural Research Forum.

The Society events are generally open to all, but non-members may be asked to pay a fee to attend some events. Membership is easy and can be arranged by filling out the attached application form. The Society would prefer that members sign up for payment by direct debit but will accommodate most types of payment. Cash payments are also accepted but on a multiannual basis for a period of five years. This is due to the high administrative cost of securing annual payments. Corporate membership is also available to companies and other organisations, however this membership does not afford voting rights.

The Society is run by a council which comprises of the offices of President, President elect, Secretary, Treasurer and Registrar in combination with other Council Members. The Council is elected annually at the AGM during the winter conference.

Application for membership involves the completion of the attached form. All applicants must complete Section A, and those opting to pay by direct debit must also complete Section B. Membership costs €50 per annum. However, a reduced fee of €20 per annum is available for students who wish to join the Society.

The SEPA (Single Euro Payments Area) rules require that ITLUS retains completed mandates (Section B below) on file.
